## Privacy Policy

The Friends of Lowther Pavilion Theatre (FOLP), understand that your personal information and privacy is important to you. We make every effort to ensure that the information you share with us is accurately recorded, retained securely and used only according to your wishes. We protect your personal information and adhere to all current data protection act legislation with respect to protecting privacy. We do not give out, sell or trade our mailing list data to external organisation, but see below regarding information shared with the Lowther Pavilion Theatre.

We comply with the Data Protection Act 1998, the Privacy and Electronic Communications Regulations (PECR) and the General Data Protection Regulations (GDPR) 2018.

Friends of Lowther Pavilion Theatre collects personal data that you volunteer as part of joining as a member. Personal information may include:

- Your name and title
- Your postal address, postcode, email address and phone numbers
- Membership status including payment details and standing order details
- Contact preferences
- Gift aid status
- Details of correspondence sent to you , or received from you
- Any other information provided by yourself at the request of Friends of Lowther Pavilion

The Membership Secretary is responsible for processing data and the data is stored electronically using Google Sheets & Docs. Your data will be retained only whilst your membership is current. If your membership lapses your data will be deleted from our records.

When we ask you to provide personal information we will let you know why we are asking, and how we will use your data, by directing you to this policy.

Data we hold may be used to send you promotional, marketing or fundraising information by post, telephone or electronic means. These types of communications may include

- informing you of other products, services or events related to Friends of Lowther Pavilion Theatre.
- News and updates about Friends of Lowther Pavilion Theatre, including postal and electronic newsletters.
- Information on fund raising operations, including occasional targeted requests to consider supporting us in various ways.

- Other relevant communications based on your relationship with Friends of Lowther Pavilion Theatre.

We want to make sure that your personal information is accurate and up to date. You may ask us to correct or remove information you think is inaccurate. If you make a request relating to any of the rights listed above, we will consider each request in accordance with the General Data Protection Regulations. No administration fee will be charged for considering and/or complying with such a request and a response will be provided within 30 days. Upon successful verification of your identity you are entitled to obtain the following information about how your personal information is processed:

- The purpose of the collection, processing, use and storage for your personal data
- The source of the personal information, if it was not obtained from you
- The envisaged period of storage of your personal data The categories of personal data stored about you
- The recipients to whom your personal data has been or may be transmitted

## **Security**

Once we have received your personal data, we will use strict procedures and security features to try to prevent unauthorised access. These will include use of security software and restricting access by password control. We will process, disclose or share data only if required to do so by law or, in good faith, believe that such action is necessary to comply with legal requirement or legal process served on us.
